

## PASLODE FUEL NAIL PACK SWEEPSTAKES

### OFFICIAL RULES

1. **Sponsor.** This sweepstakes is sponsored by Illinois Tool Works Inc., an Illinois corporation, the headquarters of which is located at 155 Harlem Ave, Glenview, IL 60025 (“**Sponsor**”). By entering, you agree to these official rules and the decisions of the Sponsor, which are final and binding. This contest is not sponsored, endorsed, or administered by Facebook.

2. **Eligibility.** The Paslode Fuel Nail Pack Sweepstakes (“**Sweepstakes**”) is open only to individuals who are legal U.S. residents, 18 years of age or older with pre-existing Internet access and Facebook and Instagram accounts. Employees of Sponsor, and their respective parents, subsidiaries, agencies, and affiliated companies and their immediate families are not eligible.

3. **How to Enter.** NO PURCHASE NECESSARY TO ENTER OR WIN.

To enter the Sweepstakes, simply visit <https://www.facebook.com/ITWPaslode/> or <https://www.instagram.com/itwpaslode/> (“**Entry Site**”), and post a picture of how you’re reusing empty fuel nail pack containers (tag @itwpaslode on Instagram) or tell us about it in the comments of the giveaway post. You must complete all required information to be eligible to enter to win a prize. Entries must be submitted between April 10, 2019 at 12:01 am and April 17, 2019 at 11:59 pm Central Time. Normal Internet access and usage charges imposed by your online service provider may apply and will be your sole responsibility. All information provided is provided to Sponsor, and not to Facebook or Instagram.

Limit one sweepstakes entry (“**Entry**”) per person. Additional entries will be disqualified, and Sponsor reserves the right to disqualify any person that submits multiple entries. In the event of a dispute over the identity of an entrant, Entry will be deemed submitted by the authorized account holder of the Facebook or Instagram account associated with the Entry (the “**Entrant**”).

“Authorized account holder” is defined as the person assigned to an email by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. Every Entry must be manually keystroked and manually entered by the Entrant. Should a prize notification or prize addressed to an Entrant be returned as undeliverable or unanswered, Sponsor may not make any further attempts at deliver. In that event, Sponsor may, in its sole discretion, disqualify that Entrant and select an alternate winner or award no prize. Any alternate winner will have the same rights and obligations as the original winner.

6. **Expenses, Taxes, and Fees.** All expenses not specifically mentioned herein are not included and are solely each winner's responsibility.
